It was a year ago when I accepted the Superintendent position here at Loomis Public Schools. I love to reflect on the time. I wouldn't say that it is a stress-free position, but I have enjoyed being able to continue working with such wonderful people. We are fortunate to have such a warm and caring staff. Some people have probably heard, but the school recently had a boiler go down in the high school. This is disappointing due to the boiler only being 15 years old. I know that this school isn't the first school to have to go through something like this, but unfortunately, we have to spend the money to have this issue fixed. The school is ok to have 1 boiler functioning to deliver adequate heat to the building. We are getting plans together to have this issue fixed and luckily have had no issues with the current boiler that is still running. Thankfully we have had some good companies in to help us figure out the best plan to fix this.

The end of February is an exciting time for wrestling, basketball, speech and FFA. Our student athletes have the opportunity to showcase their improvement throughout the year with conference, districts and state. I would like to wish them the best of luck to those competitors in the post season. We currently have 77 students 9-12. This is 4 more students that last year. 67 of those students are participating in a winter activity. That is 87% of the students that are involved in something outside of the school day. This number is well above the national average of 78%. I applaud those students and want to continue to encourage all students to be involved in an activity outside of the school day. The benefits of participating are valuable to their work ethic and their future. We offer FFA, Speech, Cheer, basketball and wrestling during the winter months.

Our teaching staff, coaches and sponsors also need a shout out! They create, build and push student relationships and encourage our students to get better every day. I appreciate their effort, ability, patience and attitude to get the students through the subjects, days, months, quarters and semesters. January is always a tough month dealing with sickness, activities and still trying the get through the curriculum, while still making it to practice after the school day is finished.

Winter Sports

Winter Sports are rapidly coming to a close with FKC tournaments in full swing for both basketball and wrestling followed by districts and state. Congrats to the Boys Wrestling Team for qualifying for State Duals this Saturday at UNK. Girls District Wrestling is this Friday and Saturday in Ord. Boys Districts are in Shelton next week. Girls State Wrestling is February 17 & 18 (Tuesday and Wednesday). Boys State Wrestling is February 19, 20, & 21 (Thursday, Friday, and Saturday). State Cheerleading is February 20 & 21 (Friday and Saturday). I hope you can come support these athletes.

Attendance

With winter comes cold and flu season. It is important for students to be in school, however, if your child is sick (throwing up, Strep Throat; etc.), keep them home. If they are sent home from school they will need to be 24 hour fever free or have a doctor's note to return. If they are gone and there is an activity the next day, they do need a doctor's note to be cleared to participate in the activity. Kids don't like to miss practice or games, however, if there is a chance of them being contagious it could affect their entire team.

Attendance is mandatory and we have to keep records on **EVERY** absence. We send out reminders at 5 days, 10 days, 15 days, and 20 days. We also have regular contact with the county attorney's office about absences. It is a state statute that students who have accumulated 20 absences are automatically reviewed by the County Attorney. Any time you acquire a doctor's note for an absence, that absence will not count against you. For example: if I have 22 absences and have 15 doctor's notes (medical, dentist, eye, counselor, PT, etc.) those 15 absences will not count. Partial day absences will add up, though. We look at 20 total days and above. Get doctor's notes whenever possible.

Logann Collin: Licensed Mental Health Practitioner with a Master's of Social Work. Serves Loomis Public Schools via a contract with ESU11.

What is your role?

- I am a member of Loomis Public School's three-person wellness team.
- I act in many roles to enhance the awareness of mental health needs and services.
- I promote community understanding of mental health.
- I assist students with academic concerns, mental health, career readiness, and social-emotional wellness.

How long have you been in this role at LPS and in other roles?

- 2nd year serving LPS.
- 4 years experience in a school role
- 8 years in social work

Tell me about your journey to becoming the professional you are today.

- I am a third generation social worker–My mom and grandma were social workers.
- Personal interests, family and other connections led me to this career.
- I wanted to help others during the expansion of a program for mental health services where it had not been available.

What do you enjoy most about your role?

- Relationships that I build with students and staff.
- I get to do one on one and [influence] a broader culture in the building.
- I address needs of the community-a larger scale.

What is the most challenging aspect of your role?

• The uncertainty of my placement-I may be building a program for change and then that opportunity changes.

What would you most like Loomis students, staff and patrons to know about you and your role?

- People can come to me; I am a safe person to talk to.
- I also have a broader role than just one on one "sit and get." [That means traditional one on one talk therapy techniques].
- I design and implement interventions that are for groups to help develop emotional citizenship. An example is "My Best Me" [K-12 social-emotional curriculum used at LPS] to help kids function as citizens by regulating their emotions.
- I help develop policy.
